Roundtable: Charting a Course for Sustainable Finance Cooperation Informing the Paris Summit in the backdrop of India's G20 Presidency

Organised by AFD CEEW and Shakti



Ahead of the G20 Leaders' Summit in New Delhi in September 2023 (G20 Summit), and the Summit for a New Global Financial Pact in Paris in June (Paris Summit), Shakti, Agence Française de Développement (AfD), and the Council on Energy, **Environment and Water** (CEEW) held a roundtable discussion on May 18, 2023, to understand expectations and inform policy discussions. Vatsala Joseph, Interim CEO, Shakti, set the context. She

said, "Global South currencies are losing to the global currencies and this trend means that their existing debts are costlier to repay and borrowing becomes difficult and most nations in the Global South have a reverse trade deficit in terms imports vs exports. Technology transfer, debt financing at low costs is urgently required with longer durations of repayment. Increased liquidity made available to take those steps will ensure concerted efforts in helping the federal structures in these nations to work on slowing down the impacts of climate change." Pathways for Lowering Carbon Footprints in Tamil Nadu



Department of Environment, Climate Change & Forest organised an event on June 8, 2023 called 'Carbon Neutral Nilgiris'. The objective was to brainstorm on how the Nilgiri district, one of the 4 districts in Tamil Nadu that intends to become carbon neutral, can move towards the goal of carbon neutrality. Vasudha Foundation undertook a quick analysis and presented the same to the group. Shakti was invited to be part of the discussions.

On 9 June, 2023, Tamil Nadu Governing Council on Climate Change held the first meeting of sectoral sub-committees under the leadership of the Governing Council members. This committee was formed after the first Tamil Nadu Governing Council on Climate Change meeting chaired by the Hon'ble Chief Minister earlier this year in March 2023. This meeting discussed various pathways and strategies that will steer the state towards achieving the goal of Net-Zero. Shakti, as part of the climate finance sub-committee, along with WRI India, presented some ideas to be considered as the state moves towards net neutrality.

Plenary Session: Electric Transportation in the Global South at the FORTH Mobility Roadmap Conference



Forth Mobility organised their Roadmap Conference on May 15 - 17, 2023, at the Oregon Convention Center in Portland, Oregon. This Mobility Roadmap Conference is an annual electric transportation event where leaders convene to bring about transformation in the movement of people and goods. The conference brings industry and community leaders together in a highly interactive format to network, forge partnerships, deepen relationships, explore emerging trends, share best practices, and build the road ahead. Priti Shukla, Programme Manager, Electric Mobility, Shakti, was invited to be a part of the panel discussion on 'Electrification in the Global South' where she shared, "Philanthropy as a community needs to unlock four levers in order to maximise its potential and enable it to make a greater impact. Ambition, Action, Accountability and Advocacy - by actively pursuing these four levers and collaborating across regions, we can ensure greatest possible impact on the EV ecosystem." Read more.

Accelerating Net Zero Transition of Public Transportation in Kolkata

TERI organised a workshop with an aim to address the multifaceted challenges envisaged by the West Bengal Transport Corporation (WBTC) in terms of electrification of public transportation systems in Kolkata, which include induction of electric buses, the revival of the tram network, or electrification of ferries through selection of appropriate technology based on specific segments, innovative procurement, business models, availability of power infrastructure, etc. Priyadarshini Alok, Assistant Programme Manager, Electric Mobility, Shakti, attended the capacity building programme, where she presented the various financial models for deployment of the e-Bus in Kolkata. She said, "The transition to electric buses requires a fundamental shift in financial planning because of multiple emerging business models. The cost structure of bus operations has fundamentally shifted from capital heavy to operationally light. With innovative policy levers, STUs can tap this great opportunity for attracting external capital for e-Bus transition." Read more.

Cities can also be crucial actors in the acceleration of electric vehicle adoption and for that to be

successful, long-term vision, awareness and education, supported by planning and coordination between city stakeholders during implementation, is required. On May 10, 2023, Vivek Chandran, Director Climate Insights Unit and previously the lead of Cities and Transport, moderated a panel discussion organised by International Council for Local Environmental Initiatives (ICLEI), South Asia, to discuss the need for city-level e-mobility action plans and the consideration that could go into their making. He highlighted the unique role of city governments in accelerating the adoption of EVs and hasting the speed at which benefits could be accrued to urban residents. The event was attended by participants from four countries - Bangladesh, Sri Lanka, Zimbabwe, and India. During the launch of 'Centre for Sustainable Finance' by Climate Policy Initiative, India, on April 26, 2023, in Mumbai, Shubhashis Dey, Director Climate Policy and Climate Finance, Shakti, participated in a panel discussion 'Increasing Green Finance: From ambition to action'. He said, "It is a question worth considering whether policy follows markets or markets follow policy. This varies across different regions and countries. In EU, for example, the ESG and sustainable markets came up and policy was created, and continues to be created, to create guardrails. In the Indian ecosystem, this has been quite the opposite where markets have followed policy signals'. Read more.

Roundtable: Evolving Indian Environment and Climate Change Priorities, Canadian priorities, Programming, Possible Opportunities for Collaboration



At a roundtable organised to discuss evolving Indian environment and climate change priorities, Canadian priorities, programming, and possible opportunities for collaboration, on the occasion of the visit of Mr Stephen de Boer, Assistant Deputy Minister of International Affairs, Environment and Climate Change Canada, the High Commission of Canada to India, Shubhashis Dey, Director Climate Policy & Climate Finance, Shakti, spoke on India's climate finance state of the sector situation – that India needs an upward of \$150 billion per annum to achieve its NDC commitment and the current flow is around \$45 billion per annum and that private finance flow/ investment from Global North to India at scale is currently missing. He highlighted that the recent protectionist financial policies in Global North have further limited the finance to Global South by creating artificial demand in developed countries. He emphasised that to solve the global climate crisis it is important to move away from the traditional construct of finance and economic rationale to a climate and human first approach. Read more.


